### PHILOSOPY APPROACH

### **OUR EDUCATION PHILOSOPHY**

At our School, we are committed to providing an education that is aligned with the Common European Framework of Reference for Languages (CEFR) and meets the strict standards of international accreditation bodies. We believe in fostering an inclusive and dynamic learning environment where students are encouraged to develop their language skills through immersive and practical experiences. Our philosophy emphasizes personalized learning pathways, cultural awareness and continuous assessment to ensure that each student reaches their highest potential in language proficiency.

### **METHODOLOGICAL APPROACH**

Our methodological approach is designed to be in line with the latest Common European Framework of Reference for Languages (CEFR) criteria and provides a comprehensive and effective language education from A1 to B2 level. This includes;

English A1, A2, B1.1, B1.2 and B2, German A1, A2.1, A2.2 and B1.1 French A1, A2.1, A2.2 and B1.1 levels.

We prioritize an immersive and communicative language learning experience and promote a student-centered environment that encourages active participation and practical application of language skills. Our curriculum is structured to progress smoothly through the CEFR proficiency levels, emphasizing the development of listening, speaking, reading and writing skills. We integrate authentic materials, cultural components and technology to develop linguistic competence and cultural understanding. Through task-based activities, interactive exercises and real-world scenarios, we aim to equip learners with the language proficiency and cultural awareness necessary to navigate confidently in a variety of contexts.

# EXEMPTION EXAM AND PLACEMENT TEST -1



### SFL Exemption and Placement Exam (MDBS)

In the 2024-2025 Academic Year, exemption and placement exams will be conducted together. These exams will be carried out in three stages.

In the first stage, all our students will be taken in groups to the supervised online exam in the computer laboratory located on the ground floor of our School. In this exam, students will be asked separate questions from all levels, starting from A1 level, in German, French, and English\*, according to their departments and based on the exam results, up to their target levels. If the student successfully completes the exam at their target level in this stage, they will be eligible to take the second and third sessions of the exemption and placement exam. If the student fails at any level in the first stage, they will start the preparatory program education according to the level\*\* at which they failed. In the first stage, students will be asked questions on listening, reading, grammar, and vocabulary at each course level.

Newly registered students\*\*\* at our university who wish to take the optional English preparatory program will only participate in the first stage of the exemption and placement exam. Based on the results of this stage, they will begin their preparatory education. Students who wish to take the optional preparatory program and get a score of B1.1 or higher level in this stage will be transferred to their departments to start their education from the first year.

Students who pass all course level exams in the first stage will proceed to the second and third stage exams. In the second stage exam, their writing skills at the target level will be assessed, and in the third stage, their speaking skills at the target level will be evaluated. Students who score a total of 70 or above in all stages will be exempt from the preparatory program and will start their education in the first year.

- \* Students of the Translation and Interpreting Department will take two separate exams in French and English.
- \*\* Students who have to repeat the program will continue their preparatory education from the last level they successfully completed, provided their first stage exam result is higher than the level they finished in the previous year.
- \*\*\* Students who have previously enrolled in the optional English preparatory program and were unsuccessful will be eligible to take the second and third stages of the exemption and placement exam, provided they succeed in the first stage.

All students are required to take the 1st stage of the Exemption and Placement Exam.

# EXEMPTION EXAM AND PLACEMENT TEST -2

### YABANCI DİLLER YÜKSEKOKULU

### Students who will take the MDBS;

- -Students enrolled in the university for the first time in 2024-2025 who have a compulsory preparatory program:
  - Department of German Language and Literature
  - Department of French Language and Literature
  - Department of English Language and Literature
  - Department of English Language and Education
  - English Translation and Interpreting Department
  - Department of Nanotechnology Engineering,
- -Department students who have studied the preparatory program once and repeat the class and have a compulsory preparatory program,
- -Students who enrolled in the university for the first time in 2024-2025 and who want to study the optional English preparatory program\*,
- -Optional foreign language program students who have studied the preparatory program once and failed\*\*
- \* The list of the departments that enroll to the university for the first time in 2024-2025 and have an optional preparatory program is available at ydy.cumhuriyet.edu.tr.
- \*\* Students who have previously studied and failed the optional English preparatory program must submit a petition to the School Directorate until the end of working hours on Friday, September 13, 2024 that they want to take the MDBS.

### Who cannot take this exam?

- -Students of Turkish departments that do not have a compulsory or optional preparatory program,
- -Students who have studied the preparatory program twice and failed,
- -Foreign students who have enrolled in our university from the International Student Quota and do not have a Turkish proficiency or exemption certificate. (It will be checked from the Öbs system.)

There will be no make-up for exemption and placement exams.

# EXEMPTION EXAM AND PLACEMENT TEST -3

### <u>International Exams That Can Be Used For Exemption</u> <u>From The Preparatory Programs</u>

According to Article 8, paragraph 1, subparagraph c of the School of Foreign Languages Regulation, the exemption exams and scores for the compulsory preparatory classes starting from the 2024-2025 Academic Year are as follows:

These test scores can only be used for exemption from the preparatory program and cannot be used for transfer between courses.



# EXIT TESTS

1 academic year consists of 4 quarters and one course is given in each quarter. Each quarter will last 8 weeks, and course completion exams will be held in the last week. All language skills will be measured in these exams. Course completion exams affect your total course final score by 60%. Your preparatory class success score will be calculated by taking the average of your end-of-course success scores.

Absentee students cannot participate in this exam. Students who are successful in this exam move on to their departments after completing the upper level or preparatory training according to the target CEFR level of their department. Unsuccessful students repeat the last course they took in the first quarter it is offered. Students who cannot successfully complete the compulsory preparatory class within two years are dismissed from the program.

The School Board decides on the acceptance of students' excuses regarding the course completion exam that they were unable to take. Applications regarding excuses must be made to the School Directorate within seven days following the exam date, together with the required documents. Applications made after this period will not be processed. The petition required for this is given in the last section of this handbook.



# **ASSIGNMENTS**

### **QUIZZES and ASSIGNMENTS**

A quiz is given in the 4th week of each course. In this exam, reading, listening, language use skills and speaking skills are measured. In addition, throughout the course, instructors give assignments specified in the syllabus. Assignments and quizzes given during the course constitute 40% of your course completion score. There are no make-up exams for quizzes and assignments.

### **ARTIFICIAL INTELLIGENCE POLICY**

It is forbidden to use artificial intelligence in the preparation of assignments given by faculty members. In cases where the use of artificial intelligence is detected, this situation will be evaluated within the framework of cheating and the student will be suspended from school in line with the relevant disciplinary regulations.

### **CONDUCTING THE EXAMS**

In face-to-face exam programs, students take the exams on the specified dates, places and times with their student ID or current student documents. It is mandatory to comply with the exam rules and the instructions of the examiners. The exams of students who do not comply with these rules will be deemed invalid and necessary disciplinary action will be taken against these students.

Students have the right to object to their grades within 3 business days from the announcement of the results of the exams they have taken. Applications made after this period will not be processed. The petition required for this is given in the last section of this handbook.

There is no make-up exam for exemption and placement exams, make-up exams and quizzes.

### FEEDBACK ON EXAMS AND ASSIGNMENTS

Instructors give feedback to students after assignments and quizzes. Feedback is provided to the first draft of the assigned writing assignments on paper, and to the final version via the YDYONLINE system. Feedback for other assignments, such as worksheets, and quizzes is given in class hours. Additionally, students have the opportunity to meet with faculty members during office hours and receive feedback on other issues.

### **APPEALS AND COMPLAINT**

Students can also reach the management about any other types of appeals or complaints with a written and signed document.



### REGISTRATIONS

Students' preparatory program registrations are made automatically by the School Administration.

In order for students to be considered successful in their preparatory programs, they must successfully complete the target level determined by the School Board for their departments.


Target proficiency levels are as follows:

Department of English Language Education B2
Department of English Language and Literature B2
Translation and Interpreting (English) B2
Translation and Interpreting (French) B1.1
Department of German Language and Literature B1.1
Department of French Language and Literature B1.1
Department of Nano-Technology Engineering B1.2
Optional Preparation B1.2

The target levels are valid for our newly registered students, and the old target levels will be applied for the existing students.

An academic year in the foreign language preparatory program consists of four quarters of 8 weeks each. The maximum education period is two years. If deemed necessary, summer school can also be opened with the approval of the University Senate.

Starting from the 2024-2025 Academic Year, students in the Translation and Interpretation Department will study for 2 years in the preparatory program. This period may be shorter in cases such as exemption and placement exam, exit exam results, and exemption with documentation. For students who enrolled in previous years, the rules from the previous year will apply.



### **ABSENTEEISM**

- Each course consists of 8 weeks and there are at least 140 hours of lessons in each course.
- In preparatory programs, all students must attend 85% of these courses. Submitting a medical report or stating any other excuse does not eliminate the obligation to attend.
- Administrators and faculty members do not have the authority to give students permission.
- Students who fail due to absenteeism have to repeat the course they failed by taking it in the
  first quarter of the course and cannot continue their faculties or colleges. These students
  cannot take courses and exams following the period exceeding the absence limit.
- Optional preparatory program students must take 4 levels by the end of the year. These students cannot transfer to their departments between courses or semesters.
- Students in the optional preparatory program can continue their education from the 1st year if
  they submit a petition stating that they have decided to withdraw from the preparatory
  program by the end of business hours on Friday, September 20, 2024. Requests made after
  this date will not be accepted.



### **COURSES**

### **COURSE PROGRAMS**

Lessons are held 20 hours a week, in the morning or in the afternoon, within a 4-hour program, and are announced on the website before the courses start. The syllabi for the courses can be found on the YDYONLINE website. Students must come to classes on time, being late will not be allowed and will be counted as absenteeism. It is necessary to follow the instructions of the instructors both in exams and in classes, and disciplinary action will be taken against students who disrupt the order.

### **COURSE MATERIALS**

Students will provide the necessary materials for the course, and the announcement regarding this will be made on our website. In accordance with the Law on Intellectual and Artistic Works No. 5846, the use of unlabeled and non-original materials in the classroom is prohibited, and students are responsible for all legal liabilities that may arise. Students in this situation will not be admitted to the course and their absence will be recorded.

### **SELF-STUDY**

In addition to the 20 hours of classes per week, students are expected to study an additional 20 hours per week on an individual basis. For individual study, students can use the school library, self-access center and worksheets uploaded to the YDYONLINE system. Learners can also benefit Artificial Intelligence tools to study by themselves, as long as it is not used for the preparation of the assignments.



# EXTRACURRICULAR ACTIVITIES



In our school, extra-curricular activities that students can participate are occasionally organized. Speaking clubs, film review activities, several artistic and intellectual meetings or workshops can be listed in this context. Students can participate in speaking clubs to enhance their speaking skills. Those who are interested in cinema can attend film review sessions or other activities based on their interests.








### **YDYONLINE**
